CLASS DESCRIPTION:

INTRODUCTION:

- 1. There is a dire need for a comprehensive study of the home, as God would have it to be!
 - A. This study will be directed at the home, as the scriptures would indicate that it should be.
- 2. It is not a lesson, per se, on the "Christian home," but on the home in general.
 - A. Let me say in the beginning that I make no claim to be an authority on the home.
 - B. However, in reading after those who claim to be authorities I have come to the conclusion that I know as much or more about it than they.
 - 1. Not because I am smarter than they, but because I have read the "Owner's Manual" on the subject, the Bible, and many of them have not.
- 3. Our study will deal with the purpose of the home and conclude with seeing what God expects it to be.
 - A. We will note several statistics and consult differing materials in order to assist us in realizing the state of the home in our society.
 - 1. I am convinced that once we have realized the condition of the home in past and present generations we will be vitally interested in seeking the information needed to correct the situation.
- 4. Our goal in examining the home is two-fold:
 - A. Preventive To set forth information to encourage those who are yet unmarried to examine marriage and be aware what lies ahead.
 - 1. Often people say "Love is blind," to which I reply, "And marriage is an eye opener."
 - 2. With that in mind it seems better to enter marriage "wide-eyed" than to end up in divorce court in a few weeks, months, or years.
 - 3. We may also prevent some problems that might arise in the family life down the road by such a study.
 - B. Healing Perhaps we can discuss some wounds that might open in the future in congregations where we work.
 - 1. If there is a marriage there will be problems or disagreements.
 - A. People who say they have never had a disagreement in their marriage always cause me to want to ask, "What else do they lie about."
 - 2. Problems will come, and one should seek to be prepared for these problems.
- 5. As preachers you will find yourself having to deal with marriage problems from time to time.
 - A. The more prepared you are to deal with them, the better job you will do.

BODY:

1. FOUNDATION FACTS FOR MARRIAGE:

- A. The proper foundation for the home is God.
 - 1. No structure is any stronger than the foundation Matthew 7:24-27; Luke

6:48.

- 2. If God is not one's foundation and builder then they labor in vain Psalm 127:1.
- 3. Rely on Him and His Word in all things Psalm 37:5.
- 4. If spouses do not have respect for God, they will have no respect for each other.
 - A. This is also true the other way, if spouses have no respect for one another they will seldom have respect for God and His commands concerning marriage.
- B. God joins together.
 - 1. Matthew 19:6 "What therefore God hath joined together, let not man put asunder."
 - 2. God is a witness of this covenant Malachi 2:14.
 - 3. It is not good to be alone Genesis 2:18-25.
 - 4. Adam was alone so God made him a "help meet."
 - 5. Eve was "bone" of Adam's "bone," i.e., taken from his rib.
- C. Reasons for marriage:
 - Companionship Genesis 2:18.
 A. Not good to be alone.
 - Replenish earth Genesis 1:28.
 - 3. For sexual fulfillment 1 Corinthians 7:5; Hebrews 13:4.
 - A. This may be a difficult subject to approach, but it needs to be discussed.
- D. Marriage:
 - 1. Is permanent for life Romans 7:1, 2.
 - 2. Is a covenant before God Malachi 2:14.
 - 3. Is a leaving and cleaving Genesis 2:24.
 - 4. Demands commitment and responsibility.
 - 5. Consider 1 Corinthians 7:1-40; Matthew 19:6.A. See Appendix # 1, "Foolish Reasons for Getting Married."
- E. The vows:
 - 1. Solemn.
 - 2. "...do you take..." indicates a voluntary choice.
 - 3. "Lawfully wed," expresses the idea of being "glued to."
 - 4. Joined by God.
 - 5. Not to be severed by man.
- F. Emotions:
 - 1. Husband and wife are emotionally different.
 - A. Wife may cry and husband will have no idea why.

2. WHAT'S HAPPENING TO THE FAMILY?

- A. I really do not believe that anyone would be so ignorant of what is going on to say that such a study is not needed.
 - 1. But just in case the following will help us see the necessity of such a study.
- B. U.S. News & World Report, Article, June 16, 1980; "Bent but not Broken."

- 1. "We were all aware that there have been big changes in the family but the extent of those changes astounded us as we began to look into the situation. It seems to point to a major restructuring of our society, from tax codes to school systems."
 - A. "More than half the nation's mothers work outside the home."
 - B. "Six out of ten married women with school age children work outside the home."
 - C. "64% of all children between the ages 3 and 5 spend part of their day in facilities outside their home."
 - D. "45% of the children born in 1978 may spend at least part of their childhoods with only one parent."
 - E. "More than 2.7 million men and women live together unmarried, buying and selling houses and even raising the children of one or both partners' previous marriage."
 - F. "Live-in companions can qualify for 'palimony."
 - G. "61% of the families polled considered their family the most important element in their lives, but nearly half said family life had gotten worse."
 - 1. 39% considered the home less than most important.
 - 2. Survey not taken with a view toward religion, so these 39% did not say God was the most important.
 - H. Marriages performed in 1940 1,595,879; 1987 2,403,378; 2001 2,327,000, which is an increase of over 40%.
 - I. Divorces granted in 1940 264,000; 1987 1,166,000; 1997 1,163,000, this represents an increase of several hundred percent.
 - J. There were 1,038,000 children involved in divorce in 1987 as opposed to approximately 300,000 in 1950.
 - 1. As of 1997 there have been at least 1,000,000 children yearly that are children of new divorces.
 - L. In the period from 1970 to 1981 divorce rates increased steadily in the State of Texas.
 - 1. Since 1981 both marriage and divorce rates have dropped here, however the rate still shows an alarming number of people who are being divorced.
- C. There are several reasons for the dramatic decline of the home and incline of the divorce rate.
 - 1. Industrial progress.
 - A. According to Sociologists patterns of living have changed more in the past 250 years than in the previous 2,000 years.
 - 2. Decline of the authority of the husband and the father in the home.
 - A. "Obey" deleted from many marriage ceremonies.
 - 1. By the way if one is planning on marriage and want that part left out they don't even need to bother asking me to do the ceremony!
 - B. Our society has developed a lack of masculinity bringing on domineering behavior in the wife.

- C. Sexual problems among men.
 - 1. Seen in the "Macho Man" stereotype all talk, no action.
- D. Passive dependency on drugs (alcoholism, cocaine, crack, etc.)
- 3. Shifting role of the family.
 - A. No longer the economic unit as it was in the "olden days."
 - 1. Government has taken over.
 - 2. Too many "men" have "back problems" and welfare checks to argue against this.
 - B. Protective role has been taken over by law enforcement agencies.
 - 1. Husbands don't have to protect their wives and children anymore.
 - 2. Therefore the "ban the guns" slogans.
 - C. Education left to schools, movies, etc.
- 4. Religion left to "organized religion."
 - A. No home involvement.
 - B. Remember the bumper sticker "The family that prays together, stays together?"
- 5. Millions of frustrated wives are on the march.
 - A. E.R.A. has sought to destroy the concept of the traditional home.
 - B. Read of one group who called themselves the "Frigid Wives of Reno."
 - C. One survey stated, "Almost 50% of all wives are frustrated at the role of the wife."
- 6. Accelerated living.
 - A. Many parents have a non-restrictive attitude when it comes to their children.
 - 1. See *Ten Rules For Bringing Up/Bringing Down Children* (Appendix # 2).
 - B. Glorified sex (Movies, television, printed page, etc.)
 - 1. Most people cannot meet the "standards" set by these things.
- 7. Social pressure.
 - A. Trying to be socially acceptable at whatever the cost.
- 8. Family isolation.
 - A. Average person doesn't know his neighbor.
 - B. When people move today few from the immediate neighborhood come to visit and introduce themselves.

3. PURPOSE OF THE HOME.

- A. Genesis 2:23, 24.
- B. The home is for the procreation of the species.
 - 1. Genesis 1:28; Hebrews 13:4
- C. The home is for the nurturing and protection of children.
 - 1. Ephesians 6:4; 1 Timothy 5:8
- D. The home is for training the children.
 - 1. Proverbs 22:6; Luke 2:52; 2 Timothy 1:5; Ephesians 6:4.
- E. The home is for affection giving, supplying love and a sense of security to all

members of the family.

1. 1 Corinthians 7:1-5.

4. GETTING READY FOR MARRIAGE.

- A. This particular point is would be more relative to those who have as yet to marry, but needs to be discussed since you will be dealing with the unwed.
 - 1. However, even for those of us who are married there is valuable information herein, which we can use in the congregation of which we will be working with.
 - 2. If we can stop the tendency to enter marriage with one's eyes closed we will see a change in the divorce rate.
- B. Who to date?
 - A. Only date a person you would want to marry.
 - 1. To date a boy or girl with the idea of, "Well, I don't like him, her, but I'll date them because no one else has asked" is playing with fire.
 - 2. Since one marries someone they date, people should be encouraged to date selectively.
 - B. How to choose a date?
 - 1. Selection of dates should be wisely chosen by youth in the church especially.
 - A. However, to grab the first guy, gal, who comes along and then spend three hours getting ready for the date doesn't make sense.
 - 2. In the selection of a date certain social, religious, and intellectual rules should be followed carefully.
 - 3. The date should meet the approval of parents, normally.
 - A. Some parents will never approve of anyone.
 - 4. Should be within ones own age range, background, and intelligence.
 - 5. If at all possible date those of ones own religious group (i.e. the church).
 - A. Dating those of other "faiths" or no faith is dangerous.
 - B. 2 Corinthians 6:14.
 - 1. I can promise you, if you marry a child of the devil, and you are a faithful Christian, you are going to have problems with your father-in-law!
 - C. "In a study of 13,528 young people in Maryland between the ages 16-24, the following is impressive" (Wilmeth, P.D., The Christian Home, 1955, p. 33.)
 - 1. Divorces in the homes were on this wise:
 - A. Where both parents were Jewish 4.6%.
 - B. Where both parents were Catholic 6.4%.
 - C. Where both parents were Protestant 6.8%.
 - D. Where religions were mixed 15.2%.
 - E. Where there was no religious affiliation 16.7%.
 - D. "Of every Christian marrying out of the church, it is estimated that only 20 convert their companions, 24 live a divided church life, and 56

quit the church. Statistically, ninety out of each hundred divorces occur in homes divided religiously, while only two occur where both husband and wife attend church services. Of marriages which result from association on Christian College campuses, divorce marks the end of only 1 out of 800." Curd, Bruce R., Marry Only In The Lord, 1975, Appendix II.

- 1. It is my belief that if "Christian Colleges" existed for no other reason than serving to put marriageable young people together this would warrant their existence and support.
- 6. If the boyfriend or girlfriend is not a member of the church one should encourage them to attend services while dating.
 - A. If they will not attend while trying to "win another's love" chances are great that they will not do so after marriage.
- 7. The chances of "falling in love" should always be kept in mind while dating.
- 8. Note *Test for boyfriend*, *girlfriend* (Appendix #'s 3 and 4).

5. MARRIAGE.

- A. What is marriage?
 - 1. Genesis 2:23-25.
 - Union of one man and one woman until death.
 A. Matthew 19:4-6; Mark 10:6-9.
 - A divine institution witnessed by God.
 A. Malachi 2:14; Matthew 19:6.
 - The filling of a void in man's life (companionship).
 A. Genesis 2:18.
- B. What marriage is not:
 - 1. Not a 50/50 proposition!
 - A. Rather a 100/100 proposition.
 - B. If only 50/50 proposition then each one is only giving half of their self to their mate.
- C. Essential ingredients of a successful marriage.
 - 1. Observe the spirit of "E Pluribus Unum."
 - A. One out of many.
 - B. The family is a single unit made up of several members.
 - C. To be successful in the home life we must adopt the attitude of "one for all, and all for one."
 - 2. Live according to the "Golden Rule."
 - A. Matthew 7:12.
 - 3. Freely forgive as requested.
 - A. Implies two thoughts.
 - 1. The realization of the one, who erred against the other of their action, seeking to be forgiven.
 - 2. The willingness of the one "sinned" against to forgive.

- B. Matthew 6:15 (This passage applies to your marriage partner too.)
- C. 1 Corinthians 13:3.
- 4. Put God and spiritual matters first. A. Matthew 6:33.
- 5. Don't be a "mote hunter."
 - A. Matthew 7:1-5 (Just as applicable to the home as any place else.).
 - B. "There is so much good in the worst of us, and so much bad in the best of us, that it hardly behooves any of us, to find fault with the rest of us."
- 6. Develop common interests.

A. Not natural, but necessary.

- 7. Be willing to communicate.
 - A. I suppose that the majority of marriage problems that I have dealt with have originated right here.
 - B. Communication involves the expression of one's ideas or feelings by words, looks, or actions.
 - C. Talking is only one side of the two-way street of communication.
 - 1. The other side is listening.
 - 2. People sometimes say, "I really try to communicate with my spouse, but they just won't listen."
 - A. Their tongue is hinged in the middle and they think they are the only one who has anything important to say.
 - 3. Sometimes I feel that the only solution to this sort of a problem is a gag.
 - A. I think at times that when certain individuals die someone is going to have to take a club and beat their tongue to death later.
- 8. Watch your words.
 - A. Speak kindly and softly.
 - 1. The tone of speech means much.
 - B. Think before you speak and in some instances your thinking will keep you from speaking at all.
 - 1. Proverbs 15:1.
- 9. Be thankful.
 - A. This is a commandment Colossians 3:15.
 - B. It is much more profitable to count your blessings than it is to count your mistreatments.
 - 1. Or your child support checks.
- 10. Dare to discipline.
 - A. Modern psychology might disapprove, but the Bible plainly teaches discipline.
 - 1. Proverbs 13:24.
 - B. Proper chastening is evidence of love.
 - 1. Hebrews 12:5-10.
 - C. Years ago everyone was throwing everything to the wind and allowing Spock to set the pattern of child rearing.

- 1. Then he came out in print admitting he had been wrong.
- D. God has set the true pattern and has not changed it.
- 11. Keep your promises.
 - A. It is better not to vow than to break your commitments.
 - 1. Ecclesiastes 5:5.
 - B. Husbands and wives should keep their vows made at the time of marriage, and their promises made to their children.
 - 1. One of the best ways to teach our children honesty is for us to be honest and promise keepers.
- 12. Refrain from childishness.
 - A. Grow up!
 - 1. Be mature!
 - B. Determine not to act like a spoiled baby.
 - 1. In all your actions seek to show maturity and remember to put away childish things 1 Corinthians 13:11.
- 13. Practice "show" and "tell."
 - A. Don't be afraid to tell those in your family of your love for them.
 - B. Teach your children to love their future spouse by loving the one you have.
- 14. Be patient and allow time for needed changes.
 - A. Note charts showing marriage and divorce statistics (Appendix # 5).
 - B. The highest number of marriages end in divorce in the first two years.
 - C. Love is patient 1 Corinthians 13:4.

6. SATANIC ATTACKS UPON THE HOME AND FAMILY.

- A. Humanism (euphemism for atheism).
 - 1. Humanism has made a concerted and influential attack upon the home within recent years.
 - 2. The growing atheistic community has made it clear that they do not "venerate the sanctity of the home."
 - A. The Humanist Manifesto 11 (September/October, 1973), promotes divorce, abortion, euthanasia, and freedom to explore and engage in a variety of sexual life- styles (e.g., pre-marital sex, extra-marital sex, homo-sexual activity, etc.).
 - B. Furthermore, it suggests that the authoritarian structure of the home (rules, regulations, etc), should be replaced by the principle of participatory democracy (i.e. majority rule).
- B. The Feminist Movement.
 - 1. See article "Unhappy mix of military duty and motherhood" (Appendix # 6).
 - 2. The modern feminist movement has been described as a revolt against marriage and the home.

A. Feminists are avowed enemies of the "institutional home."

3. "Mary Kassian, a former Feminist, writes of the coming holocaust of the Feminist philosophy. In her powerful book THE FEMINIST GOSPEL

(Crossway: Wheaton, 1992), she concludes: 'The social and political agenda of the feminist movement expanded as the philosophy of the movement evolved. Women initially wanted to overcome their biological differences in order to be equal with (i.e., the same as) men. They thus sought legal freedom for abortion, changes in marriage and divorce law, tax reform, universal day care, pay equity, affirmative action in employment, and changes in language. In the second phase of development, their agenda expanded their attention from naming themselves to naming their world. They emphasized female strengths and women's capacity for love, acceptance, peace and empathy; and added issues such as ... homosexual rights, aboriginal rights ... Finally, feminism moved into a third phase of spiritual awareness. By the time feminism had reached its third phase of development, its earlier goals were well on their way to being realized. North American society had moved toward accepting and integrating the feminist view of abortion, day care, divorce, sexual liberty, and affirmative action into common policy. The agenda ... had also progressed toward mainstream integration. The mainstream acceptance of the feminist agenda caused the movement to lose its distinction. ... Feminists are becoming difficult to identify, not because they do not exist, but because their philosophy has been integrated into mainstream society so thoroughly. The philosophy is almost unidentifiable as feminist, for it is virtually indistinguishable from mainstream,...(pp. 250-251).""

 - A. The liberation of womankind from what they view as the degrading roles of wives and mothers; the freedom to eliminate children (by abortion), or to have their children reared in government supported child-care centers; the promotion of lesbianism, etc.

 A. How tragic it is to see members of the church supporting this ungodly movement!
- C. The Sexual Revolution.
 - 1. Marital fidelity has become a joke to many.
 - A. Sexual scandal in government is common news.
 - B. "The recent report of a Census Bureau survey found that married-couple households in the U.S. are now outnumbered. A hair more than half 50.3 percent of households are headed by unmarried people,..."

- 1. MSN report of an article entitled Look who's happily unmarried.
- C. "Infidelity rates are getting higher and higher in the American society. Here are some infidelity statistics based on a survey by the National Opinion Research Center at the University of Chicago:
 - 1. 25 percent of men have had extramarital affairs
 - 2. 17 percent of women committed adultery."

 - 1. Talk about gays and gayness as loudly and as often as possible.
 - 2. Portray gays as victims, not as aggressive challengers.
 - 3. Give homosexual protectors a just cause.
 - 4. Make gays look good.

 - B. "At two cents per call in New York City, one major Dial-A-Porn provider earned sixteen thousand a day and a total of \$3.6 million for the year ending February 28, 1984" (ibid. p. 366).
 - C. "Pacific Bell estimated that their company earned twelve million from Dial-A- Porn calls between October 1984 and October 1985" (ibid. p. 366).
 - D. In 1984 the top ten selling sexually explicit magazines averaged 10,617,482 magazines per month in sales (ibid. p. 359).

- 4. Sexual aggression.
 - A. According to the FBI "Rapes by boys 18 or younger rose by 14.6% between 1983 and 1987." AFA Journal, Feb. 1990, p. 9.
 - B. "CBS noted that a recent survey says one in six college women reported being a victim of date rape or attempted rape during the preceding year, and one in 15 boys admitted to being the perpetrator of date rape or attempted rape". AFA Journal, Jan., 1990, p. 8.
 - C. "A UCLA psychology professor named Neil Malamuth questioned 288 young men of college age on matters of sexual aggression. His findings were reported in the Journal of Sex Research. One of his questions was: If you knew you could get away with it, would you rape a girl? One-quarterone out of four, 72, young men out of the 288-said they would commit rape if they knew they could get away with it." AFA Journal, Sept., 1990, p. 18.

 - F. "56% of females will be confronted or hurt sexually.
 - 1. Over 3 million women will be assaulted this year.

FOOLISH REASONS FOR GETTING MARRIED

There are a number of good reasons, in harmony with God's design for the home, for desiring to be a part of a marriage relationship. One may meet a winsome Christian person who has attractive spiritual and personal qualities that appear to be ideal for a lifelong marital union. Certainly children of God, who opt for marriage, ought to seek companions who are compatible with them, and with the Lord – someone who will be able to enhance their journey toward heaven.

It should be recognized, however, that marriage is an option, not an obligation. There are some who choose not to marry, and they seem perfectly happy and well-adjusted as single people. Others, who desire to marry, simply have not discovered a suitable prospective mate, and, with patience, they choose to wait. Perhaps they are familiar with the old adage, "Marry in haste; repent in leisure."

It is entirely possible, however, for men and women – young or older – to feel pressured to marry. Hence they may enter this sacred union rather impulsively, without due consideration for their eternal interest, and thus for a variety of wrong motives. Such a rash judgment can prove disastrous.

Marriage is an "until-death-do-us-part" commitment. It ought to be approached from a joyous, yet cautiously-solemn, vantage point. Marriage should be embraced for wise reasons, not foolish ones. Let us reflect momentarily upon some of the impetuous motives that lend themselves to the abandon of some, who rush headlong into marriage.

Some marry for financial security. All of us have heard those exotic stories of the young American girl who is romanced by, and becomes wedded to, the Middle Eastern oil baron in order to live in splendid luxury. Such cases are rare, of course, but the happiness sought in such arrangements is rarer still.

Closer to home are the situations, for example, where a daughter is reared by a shiftless, unproviding father. Determined to have the "better life," she marries the first young man who is able to offer her economic stability. Such a barter is a sorry basis for marriage, and she may learn well the heartbreaking lesson that a happy home is more than dollars and cents.

There are those who enter marriage to escape a miserable or boring domestic situation. Late adolescence is a difficult and confusing time of life. Youngsters are in a "twilight zone" of sorts. They are not ready to survive on their own, yet they have developed a sense of independence. They are restless for new adventures. If their home-life is an unhappy one (with perhaps harsh and insensitive parents), they may be tempted to quickly find a mate - simply to "escape" the misery of their present circumstance. This is a serious mistake. It may be going from the proverbial frying pan into the fire. "Escape" is not a noble motive for forming the most intimate of human relationships.

Some marry out of revenge. It is difficult to fathom the fact that there are those who would enter into such a sacred union merely out of the desire to punish another person. But the "I'll-show-you" attitude is more prominent than most would care to admit. A young lady may enter marriage to "show" her parents that they cannot control her life – particularly in the case of a young gentleman of whom they disapprove. A jilted youth may marry on the rebound – just to demonstrate that "two can play this game." But it's not a game! Marriage relationships can have eternal consequences.

Not a few have entered marriage because it's the voguish thing to do. All their friends have marital mates, why should they be left in the lurch? Peer pressure is so great at certain times in life. Far too many have impulsively "run off" to "get married" on a dare, or because others were doing it. Snap decisions can generate a life-time of bitter experiences. Marriage is not an arrangement with which to trifle.

Marriage should not be entered just to cover a mistake. In this age of lust and promiscuity, what should a couple do when they discover that a child has been conceived out of wedlock? Sometimes, a "we-must-get-married" is the quick-fix formula. In the event of such a mistake, a Christian couple, first of all, should repent – with genuine sorrow – and seek God's pardon.

Second, the couple should then devoutly consider their options. Do they really love one another, and are they committed to serving God? If so, they well may wish to marry, and put the mistake behind them.

On the other hand, if exalted qualities are not a part of the relationship, merely "getting married" is not a resolution to their problem, and it certainly will not enhance the happiness of their child. In some cases it would be far better for a young woman to wait, perhaps eventually finding a devout father for her child, than to wed her partner in fornication "for the sake of the baby."

Marriage on the basis of mere physical attraction is a foolish mistake. The grass withers and the flowers fade – and so does physical beauty. Thousands of American couples have watched the degeneration of their marriages because the relationships were grounded principally in external features.

Spiritual qualities and personality traits are the real "glue" that bonds couples in committed unions. Beauty is only skin deep, and if some were "skinned" how hideous they would appear. Our youngsters should be taught the true values that undergird lasting marriages.

Finally, it hardly needs saying, but it is the epitome of folly to marry out of desperation. It

is better to be single for life, than to live one year in a house with a hateful mate. But some are so afraid that at their "advanced" stage of life, if they don't marry soon, the bliss may never occur! The thought of that is too horrible for them to contemplate. And so, marry they must.

I have known of several cases where folks married out of "panic," only to have the relationship crumble within weeks. I cannot but be reminded of a whimsical poem I once read (author unknown). I share it with you for its humor and wisdom.

At sweet sixteen, I first began To ask the good Lord for a man. At seventeen, as I recall, I wanted someone strong and tall. The Christmas that I reached eighteen, I fancied someone blond and lean. And then at nineteen, I was sure I'd fall for someone more mature. Then at twenty, I thought I'd find Romance with someone with a mind. I retrogressed at twenty-one And found the college boys most fun. My viewpoint changed at twenty-two, When "one man only" was my cue. I broke my heart at twenty-three And asked for someone kind to me. Then begged at blasé twenty-four For anyone who would not bore. Now, Lord, that I'm twenty-five, Just send me someone who's alive!

- 8. Let him/her see your enjoyment and profit from Bible reading and prayer.
- 9. Set an example in faithful attendance and interest in the work of the church.
- 10. Be much in prayer for his/her salvation and spiritual growth.

TEN RULES FOR BRINGING DOWN CHILDREN

- 1. Let him/her have plenty of money to spend as he/she likes.
- 2. Permit him/her to choose his/her companions without guidance or restraint.

Unhappy mix of military duty and motherhood

"It's like this: I'm a woman and a mother "before I'm a soldier," - Spec, 4 Robin Williams, 360th Transportation Co., USA, at a military base somewhere in Saudi Arabia.

Williams, mother of two, couldn't hold back the sobs as she talked about her family back home in the States.

"Out here I think more about my family than about my job, and, yes, that could affect my performance if things got intense here," she told a reporter for the Colorado Springs Gazette Telegraph.

She talked about the lack of privacy, how the female soldiers never quite get used to changing their clothes in front of the men in the co-ed tents. Still, it's better than dressing in a foul latrine.

"I'm used to it," she says. "Most of the men know me and don't pay much attention. But my husband wouldn't like it if he knew."

Women in the men's latrine? Husband wouldn't like it? Children are miserable? A soldier weeps?

Is Williams a whiner, or what? Has feminist rhetoric outrun female reality?

WE'VE ALL heard about the military service as equal opportunity employer. But that means teaching men and women together how to work a computer, see the world or refuel an airplane. What's going on?

Feminism isn't thriving in the desert, where mothers who want to be home suckling their babies have only an intimate life in a tent with Willie and Joe, which brings out the sexual frustrations of everyone. The only other women are veiled and forbidden, constant reminders of hidden sexuality.

Women of the 360th, noting that the Army furnishes condoms along with the rations, ask nervously: "Who do they think those guys are going to use them with, the ladies In veils?"

Rumors fly that certain female soldiers are selling their sexual favors, and one female reporter describes how the couples wrapped in each other's arms deep in the dunes give new meaning to armed services.

Feminists have got what they said they wanted - equal rights for male and female to be deployed together. But the cost of those equal rights for the parents often has to be borne by their abandoned children.

A SOLDIER who gives birth enjoys six weeks of maternity leave, and then she's told to be ready to ship out just like a man. A soldier of a different sex could cry discrimination.

"I hate to say it because it doesn't fit with the whole scheme of the women's movement, but I think we have to reconsider what we're doing," Lori Moore, a former sergeant, told the New York Times. She was a "gung-ho careerist" until she recognized the suffering that would befall her three children, aged 3, 2 and 9 months, if she were to leave them. She settled for a general (less than honorable) discharge.

"I'm afraid the children are the unsung victims of Operation Desert Shield," she says. "There's no question that women can do this. The question is whether we should."

At least four of the 22 women scheduled to leave with the 360th were found to be pregnant, all for less than six weeks, when their regiment was called up.

"I can't say whether they did it on purpose to get out of this, but they knew we were going for more than a month," says Capt. Steve Fraunfelter, commander of the 360th. So "equal rights" comes with an asterisk, too.

Women, of course, are not authorized to engage in combat, but if war breaks out in the desert that may be a distinction without a difference, since the women who supply the front will be as vulnerable to Saddam Hussein's gas and bugs as the men.

Rep. Patricia Schroeder, the Colorado Democrat who is so eager for other women to fight that she introduced legislation enabling them to serve in combat units, says the problem lies not in women's capabilities, but in the failure of the military to provide "family care plans." She warns against "Mommy tracking" in the military.

We could, of course, assign battalions of baby sitters to provide day care in the desert. Moms could nurse between maneuvers. The children of combat could build Saudi Arabian sand castles. Everybody would be happy until the bombs begin to fall. For this, we go to war?
